FINANCIAL POLICY

Fees for Service are currently in effect as of 01 February 2018

- Patients using insurance and/or personal injury case treatment:
 - We accept True Health New Mexico, Presbyterian Health Plan, and Veteran's Choice, submit card with intake and provide your full social security number for Veteran's Choice Program Only.
- Self-Paying Patient:
 - New Patient intake, history, examination and chiropractic treatment: \$75.00. Additional charges may apply for extended treatments.
 - New Patient intake, history, examination and chiropractic treatments: senior rate, and student rate (age 14 and older with school ID) \$55.00. Additional charges may apply for extended treatments.
 - New Patient intake, history, examination and chiropractic treatment Child Rate 0-13: \$45.00. Additional charges may apply for extended treatments.
 - We offer 10% discount to Teachers, Active Military, Retirees, Military Spouse, City of Albuquerque Employees and Strategic Business Partners, Fitness Partners, Mall Neighbors and Chambers Members
 - Current patient routine office visits \$55.00. Additional charges may apply for extended treatments.
 - Current patient routine office visits senior rate, and student rate: \$45.00. Additional charges may apply for extended treatments.
 - Current patient routine office visit Child Rate 0-13 years \$30.00. Additional charges may apply for extended treatments.
 - Doctor fees for non-treatment services such as court appearance, consultation for legal matters, etc. case by case.
 - Massage Rates: 30 minutes \$35.00, 60 minutes \$65.00, and 90 minutes \$90.00 see front desk for discount rates.
 - Taping session only minimum charge: \$35.00. May be additional fee due to extent of taping area(s).
 - Cupping session only minimum charge: \$35.00. May be additional fee due to extent of cupping need(s).

Note: Apollo Chiropractic has a PATIENT NO SHOW for appointment policy fee of \$25.00. If for any reason you cannot keep your scheduled appointment time, please call the office no later than 24 hours of your scheduled appointment time. The NO SHOW fee must be paid prior to your next scheduled appointment.
